



National Youth Leadership Training 2018



Dear Unit Leader,

The **National Youth Leadership Training (NYLT) Course**, for Mecklenburg County Council is scheduled for June 25th through June 30th. The course will stress how training and good leadership is critical to the success of Scouting units. This course is designed specifically for Senior Patrol Leaders and Assistant Senior Patrol Leaders of Troops, Presidents and Vice Presidents of Venturing Crews, Captains and Program Managers of Varsity Teams, and Boatswain and Boatswain's mate of Sea Scouts, and Scouts who might serve in those positions in the coming years.

To become an NYLT trained leader, a candidate must be at least a Star Scout or equivalent, 14 years old, and has met or will be meeting the leadership positions mentioned above to register for this training course. The participant must have attended his or her own unit level leadership training to be considered for this course. The NYLT course will combine the latest leadership training with low-impact backpacking. Therefore, it is important that the Scout has good hiking, camping, and cooking skills. For the safety of the scouts it is a requirement that they wear ankle high boots throughout this week long course. It is highly recommended that all candidates have learned the following skills prior to the course: First Aid, Camping, Hiking, Backpacking, Wilderness Survival, and Cooking.

The Scout(s) must have your recommendation to be considered for this course.

Both the unit and attending youth Scout leaders will benefit in two major areas of concentration from this course: How to teach Scout skills to other Scouts and how leadership skills and practical application will make the unit youth leader more confident in running the unit.

This Course is limited to 48 participants. Registration is on a first come first serve basis and each unit can register two (2) participants and (2) alternates total. The date your **complete registration packet**, including payment for participants, is received at the Council office, will determine your Scouts' placement in the course. Payments will not be accepted for alternates at original registration. Alternates must be paid in full within 7 days of notification of being added to the course. Candidates and alternates listed on the registration form must meet all criteria in order to be considered registered,

Including:

- Completed registration form including Unit Leaders Signature (Bottom of the registration form)
- Signed code of conduct
- BSA medical form part A, B and C and a copy of insurance card

Alternates may *possibly* be called to replace "no shows," cancellations, and/or if the original candidate(s) does not meet the criteria until all spaces are filled. No payment should be submitted for alternates at time of registration. Primary candidates must be paid in full, with all forms turned in to be considered registered. **There will be no refunds after May 4th.**

You must commit to holding a post- course session with your Scouts on how to best use their newly acquired skills. With your help, this training course can make a positive difference in the lives of the Scouts and their home units.

NYLT Code of Conduct

Statement of Understanding

All NYLT course participants are selected to represent their local units and councils based on their qualifications in character, backpacking/camping skills, physical and personal fitness and leadership qualities. NYLT course participants and their parents or guardians must read this Code of Conduct and Statement of Understanding, and the Scout must agree to abide by them as a condition of participation. Ultimately each participant must be responsible for his or her behavior, and any serious misconduct or infraction of rules and regulations may result in expulsion from the NYLT Course.

Code of Conduct

1. The Scout Oath and Law will be my guide throughout the NYLT course. I agree to obey the safety rules and instructions of all staff members.
2. I understand that NYLT adult leaders are responsible for the supervision of all staff and participants, and will maintain discipline, security, safety and adherence to the NYLT course Code of Conduct. I understand that all NYLT adult leaders will abide by the Scout Oath and Law and all U.S, State and local laws.
3. I will label all my personal items and leave valuable items at home. NYLT course staff nor the BSA camp staff will be responsible for loss, breakage, or theft of personal items.
4. I will set a good example by keeping myself neatly dressed and presentable in the proper NYLT Course Uniform (Full Class A Uniform with Ankle high boots).
5. I will attend and participate in all scheduled programs and will cooperate with other NYLT course participants.
6. In consideration for other participants, I agree to follow the bedtime and sleep schedule of the NYLT course
7. I will be responsible for keeping my tent and personal gear labeled, clean and neat. I will do my share to prevent littering of the BSA camp we are using.

8. I will demonstrate respect for NYLT course and BSA camp property and be personally responsible for any loss, breakage, or vandalism of property as a result of my actions.
9. I understand that the following behaviors are expressly forbidden and will be grounds for my immediate expulsion
 - Purchase, possession, or consumption of alcoholic beverages
 - Purchase, possession, or consumption of illegal drugs
 - Possession or use of firearms or dangerous weapons
 - Possession or detonation of fireworks
 - Theft
 - Intentionally threatening or injuring others
 - Intentionally damaging property
10. I understand that serious and/or repetitive personal behavior violations, including use of Tobacco, cheating, stealing, possession of lasers of any type, gambling, dishonesty, swearing, fighting, cursing, hazing or any action which fails to show respect for an individual will result in expulsion from the NYLT course
11. I understand that serious violations of this code may result in expulsion from the NYLT course at my own expense. There are no refunds of course fees. All decision by the Course Director are final
